



Strong demand despite muted population growth, as well as underproduction in A-194 and A-195, have made the chicken market very tight with record strength seen in wholesale prices and TRQ utilization. The underlying cause of recent underproduction is an avian influenza-related chick shortage and related chick quality issues impacting broiler performance. CFC has now approved two strong allocations for the second half of 2025, which if realized will result in a more than 5% increase in total production compared to the same time last year. This should help to make up for reduced TRQ availability in the second half of 2025. Storage stock levels are currently at what may be an operational minimum, with a build-up in the Miscellaneous category driving this month's small increase.

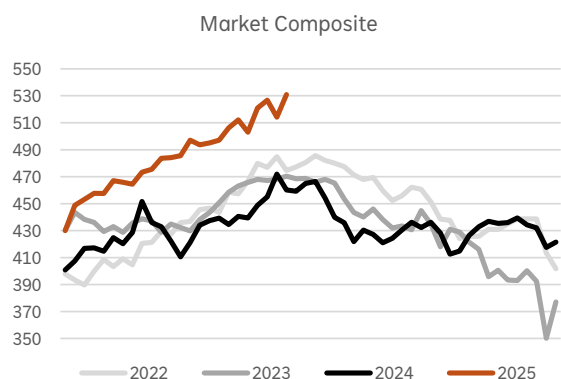
